Active Membership - \$50 per year

Open to all educational office personnel employed in an educational system or organization related to education. Members are eligible to vote on association business, serve on committees and hold office.

Retired Membership - \$30 per year

Open to individuals who were active members and have retired from employment in an educational system or organization related to education. Membership includes an annual subscription to the BEAM (retired members newsletter). Retired members shall have the privilege of voting and may serve on committees.

Associate Membership - \$50 per year

Open to all persons not eligible for active membership. Associate members have all rights and privileges of active membership except those of voting and holding office.

Institutional Membership - \$85 per year

Open to educational institutions. The institution shall be eligible to send a non-voting representative to meetings, conferences, and institutes at active membership rates.

Corporate Membership - \$85 per year

Open to businesses and corporations endorsing the objectives of the association. The corporation or business member shall be eligible to send a non-voting representative to meetings, conferences, and institutes at active membership rates.
